3. UPON REQUEST, THE UNDERSIGNED WILL PROVIDE CENTRAL VALLEY HARDWARE CO. A FULL AND COMPLETE STATEMENT OF FINANCIAL CONDITION
4. ANY DISPUTE WITH ANY INVOICE FROM CENTRAL VALLEY HARDWARE COMPANY MUST BE REPORTED WITHIN THIRTY DAYS FROM INVOICING, TO THE RESPECTIVE DEPARTMENT MANAGER IN WRITING.
